Maintenance Committee Report - August 1, 2018

Green Tops completed the oak tree trimming in Butterfly Park and palm trimming along Rivendell Blvd. They have been asked to submit a proposal for yearly oak and palm trimming as well as maintaining the beds in the various parks.

A review of contracts for community work in 2019 was completed and ideas were presented on what should be included for each contractor.

Another water leak at the Pool complex has closed the restrooms until the plumber can re-pipe the building. This is scheduled for August 17th.

The bridge renovation project is ongoing, and proposals have been obtained from different landscape contractors for consideration.

Proposals are in the works for removal and renovation of the Pump House located near the Cottages.

There was discussion on topics which included the clean-up of Pine View Path, additional park benches, power washing the fences and signs, treatment of the magnolia trees, planting behind Ibis Pond and tree planting.

Egret Pond Erosion-Control Pilot Project Launched By the Ponds & Preserves Committee



*Sustain Our

The Rivendell Board of Directors is currently reviewing our pond management policies. At the July 11 meeting, the Board passed a motion to initiate an erosion-control pilot project at Egret Pond (on Rivendell Blvd., across from the pool). The Egret Pond Erosion-Control Pilot Project is the first in a series of steps to evaluate different approaches.

Erosion is clearly visible at Egret and other Rivendell ponds, and investigation reveals that failure to take action now will be very costly later. To sustain our shorelines with effective pond management, modifications include: how we mow near ponds, aquatic plantings along the shore to stabilize the soil, and using low-toxicity approaches to control algae. We are not alone; other nearby communities are facing similar issues and addressing them as well. Opportunity for community feedback will be encouraged starting in 2019.

Giddy-up to Deer Prairie Creek Preserve - North Entrance

I don't know how many of you "sneaked" your horses into the garage when the HOA wasn't looking, but if you did, "Get thee to the Deer Prairie Creek Preserve!" There are 22 miles of designated equestrian trails awaiting. This wilderness area also offers 75 miles of unpaved trails for those who like to hike, bike or have your dog(s) sniff around to their hearts' content--in fact there are 10,128 acres of nosing about to be had!

Because we entered the park from the north, we either didn't go far enough to see the Myakka River or else it was on the other side of the adjoining property. The Myakka River must flood here because during various high-water events, I noticed residents parking their vehicles along the road, near the Border Road turn for the Carlton Preserve.

Not everyone enjoys a country stroll or a bike/horse ride in the "country," but if you're one who does, the prairie looks good. You'll see color, texture, interesting skies, trees with character, and of course, habitat for anything and everything that makes Florida home.

The next time I go, I want to go to the entrance near Tamiami Trail in North Port. A native Floridian told me that this was his favorite preserve, and, because we had been talking about the Myakka River, I'm assuming I'll see more birds and alligators there.

I'm sure there are lots of critters in the Deer Creek Prairie Preserve but they were maintaining a low profile when we came a visitin'. If you go, maybe you'll get lucky and see a bear, a panther, a bobcat, some eagles, or snakes!

Directions to North Entrance: 7001 Forbes Trail, Venice. Deer Prairie Creek Preserve is at the end of Forbes Trail and can be reached by exiting to the north from I-75 at Exit 193, following Jacaranda Boulevard to the north to Border Road, proceeding east on Border Road to South Moon Drive, proceeding south on South Moon Drive until it intersects Forbes Trail and proceeding east on Forbes Trail.

No Excuses: Get the New Shingles Vaccine, SHINGRIX

The new shingles vaccine, Shingrix, is promising, especially for older adults. It provides better protection against shingles from the start. Though Zostavax, introduced in 2006, can reduce shingles cases by about half, that overall rate conceals big differences by age. In large international trials, the new vaccine

Shingrix, prevents more than 90 percent of shingles cases, even at older ages. The 2006 Zostavax vaccine will still be available, but the CDC voted to make Shingrix the preferred vaccine.

People older than age 60 are most at risk for this blistering disease, its intense pain, its threat to vision, and the associated nerve pain that may last months after the initial painful rash that is also known as herpes zoster. Shingles is hardly a minor menace. A million cases occur in the United States each year.

Almost all older Americans harbor the varicella zoster virus that causes shingles; they acquired it with childhood chickenpox, whether they knew they had the disease or not. The virus stays dormant until it erupts decades later.

Healthy adults age 50 and older are recommended to get two doses of Shingrix, two to six months apart, to prevent shingles and reduce the course and severity of the disease.

It is recommended that patients who have had shingles, have previously received the Zostavax vaccine, or who are unsure if they have had chickenpox, receive the Shingrix vaccine. Anyone who has recovered from chickenpox may develop shingles, including children, although the risk of shingles increases as people age. The decision should be made with your healthcare provider.

COST: Patients are encouraged to contact their pharmacist or insurance provider to determine if and when their individual plan will cover the Shingrix vaccine; be sure to ask if the cost is per shot or for the two shots.

About SHINGRIX: Shingrix is a non-live, recombinant subunit vaccine approved by the Food and Drug Administration in the US and by Canada to help prevent shingles (herpes zoster) in people aged 50 or older. It is intended to generate a strong and long-lasting immune response that can help overcome the decline in immunity as people age.

Wrong Aid - Right Price

A couple, Fred and Ginger, were referred to me by their new neighbor, Glenn. Fred and Ginger had just relocated from up north. They came in for a consultation to get to know me and my office.

I opened with a common question, "how happy are you with your hearing aids?" They were never very happy with the hearing aids that they bought. They bought these hearing aids about 18 months ago, during a special pricing promotion from their northern dispenser.

Fred and Ginger had responded to a price ad for a specific aid from one manufacturer. They thought the price was reasonable and tried the hearing aids. The hearing aids were designed for a quiet lifestyle that only needed a limited technology level.

However, Fred's social life includes groups, family, travel, theatres, and dining out regularly. All of this adds up to a very demanding lifestyle.

I don't know if the dispenser up north knew enough to inquire about their current lifestyle and ask what they would like to be doing. Maybe their lifestyle was undergoing dramatic shifts, and the dispenser didn't ask what they would be involved in next year.

I do know that uncovering lifestyle habits and desires is the best foundation for selecting proper technology levels. These lifestyle issues are important to determine how much technology is necessary to hear conversations with clarity. Any aid will make sounds louder. Clarity is the key. The more complex the listening situations, the more technology is necessary to pull the speech from the noise to provide an easier listening experience.

Fred and Ginger tried the higher technology level hearing aids. During the trial, Fred said he was more relaxed and comfortable in social situations. He said he didn't strain to hear and wasn't as anxious about missing words in the conversation.
